Community Storehouse is a faith based non-profit agency dedicated to the well being and education of the children in our community. Our objective is to rebuild lives by providing real help to children, and their families, in the Keller and Northwest Independent School District.

“Real help” includes food, emergency medical, dental, vision, prescription care to uninsured children, school supplies, clothing, Christmas gifts, shelter assistance, utility support and counseling for families. In 2007, we provided services to over 3,000 children and we are projecting that over 5,000 children will need help in the coming year.
